1. Overview

ImageX provides a palette with a list of all used pictures within the front most document. Those pictures can be sorted by name, page, type, color space, color profile or resolution. Several operations on those pictures like updating and relinking are available by a context menu.

2. System requirements

- MacOS 10.4/10.5
- QuarkXPress™ 7/8

3. Installation

To install ImageX copy the file „ImageX.xnt“ into the XTensions-folder of QuarkXPress™. After restarting QuarkXPress™ a dialog for entering an activation key is shown.

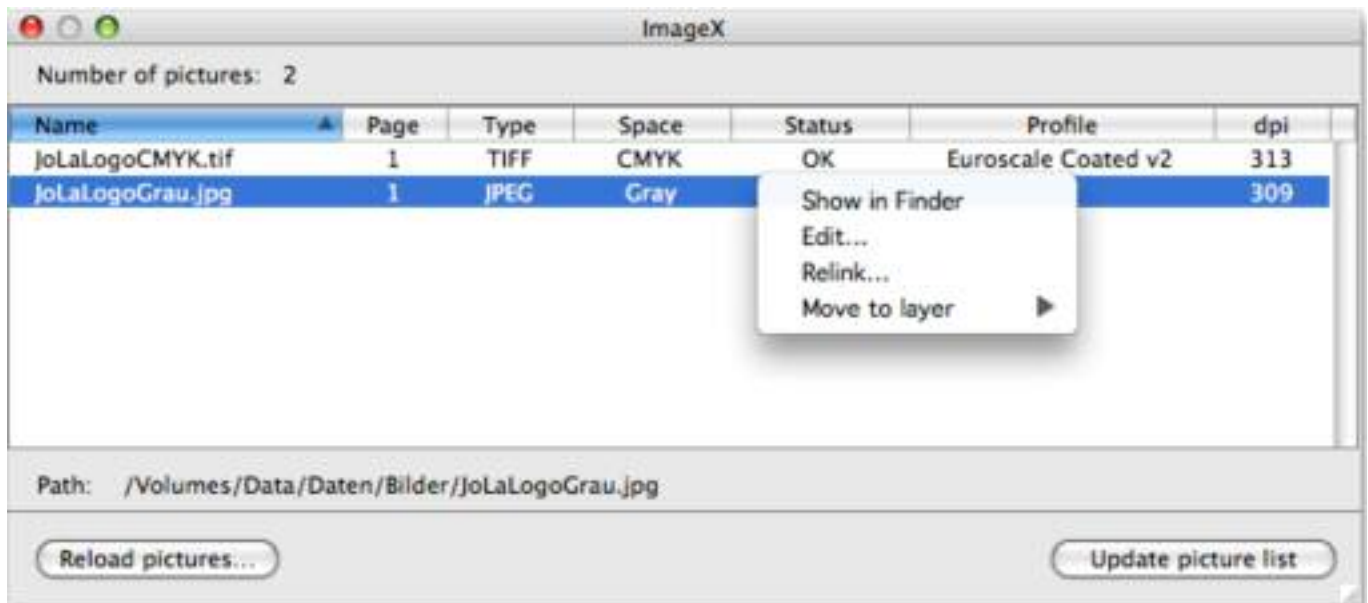


After entering the activation key ImageX is ready to use. In demo mode the context menu only works for single page documents.



4. User interface

The ImageX palette can be shown or hidden by choosing „Window->ImageX“. A list of all used pictures with a lot of information about each picture like name, page, type, color space, status, embedded profile and resolution. The list can be sorted by any of those properties. The list is updated after showing the palette or opening a document. After layout changes the update must be done manually with „Update picture list“.



By clicking on the list with the right mouse button (or control-click) a context menu pops up with several actions possible to apply to the selected pictures.

- Update (if modified)
- Show in Finder
- Edit
- Relink with current settings, even for more than one image
- Move to layer, even for more than one image
